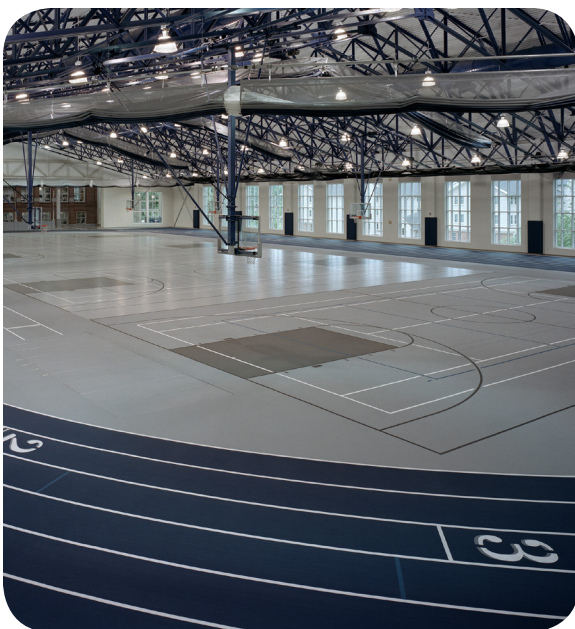
PIONEER SHOOTOUT INFORMATION
